GGCF GRANTS HELP NONPROFITS

\$6000 in grants were awarded to Dawson County Arts Unlimited for art classes, Neighbors Helping Neighbors for signage and to DCC for student bicycles. Jennifer Wheeler and Eloise True led two weeklong 3-hour Summer Art Camps with grant money awarded to The Gallery.

The Art of Endangered

made a paper mache
animal, sewed denim

clay bird nests and mirrors with nature scenes

LEGACY PRIMER

Q: What is a legacy gift to a charity?

A: Think of a charitable legacy as a post-life gift that you structure in advance. Legacy gifts are often referred to as planned giving.

Q: What assets can be used to make a legacy gift?

A: Like the gifts to charity that you are already making during your lifetime, cash, stock (especially highly-appreciated stock), real estate, life insurance, an IRA beneficiary designation (which is extremely tax effective), are examples of assets that can be a legacy gift. A legacy gift can be expressed in your estate planning documents as a dollar amount, percentage of the whole, or a legacy gift of the assets themselves. You will want to choose assets carefully, enlisting the expertise of your financial planner or attorney to do so.

Q: How is a legacy gift actually made?

A: Legacy gifts are typically spelled out in detail in your will or trust documents. This is especially important because after you are gone, too much is otherwise potentially subject to hearsay or conflict. A surprising 2 out of 3 Americans have no estate planning documents, but you can put GGCF as a beneficiary on retirement accounts.

Q: What are some particulars to be aware of?

A: Most legacy gifts can be revoked or altered through beneficiary or will changes during your lifetime. This is an important feature, as you can include charitable giving in your estate plans but still be flexible to your family needs.

Q: What tools does the community foundation offer to help?

The website www.mtcf.org is a wealth of accurate information. Partner with professionals to help you and your financial advisors take advantage of the MT Endowment Tax Credit and estate planning to help you meet your family's philanthropic and financial goals.

Glendive has seen its share of fire tragedy lately but we are resilient and there are heroes around every corner. A huge thank you to our fire fighters and law enforcement and to every one of you who picks up litter and shares random acts of kindness.

Glendive is full of opportunity with our perfect location bisected by the Yellowstone River and Makoshika Park in our back yard. Glendive's best asset is the people. They rise to meet any crisis or challenge.

One way we do that is to invest in Glendive—either now or leaving a legacy that will continue to improve our community and county for years to come. A bonus of helping our nonprofits is saving tax dollars.

If you are 73 or older, you must take a Required Minimum Distribution from your IRA or receive 50% penalty. If the RMD goes directly to the charity there are no tax consequences. Thanks to several donors we will be granting out \$10,000 this spring to worthy projects. You can also given more, up to \$100,000 through a Qualified Charitable Distribution from your IRA.

You have been giving for years. Have you thought of giving through your estate plan? A particularly useful technique is to establish a fund at the MT Community Foundation that spells out your wishes for charitable distributions to specific organizations. Your estate planning documents can, in turn, simply name the fund as the beneficiary of charitable bequests. It can be revised at any time.

There are a variety of ways to give, including contributing to an existing fund or starting your own. If you would like to start your own Donor Designated Fund, you and others have up to five years to grow a gift of \$25,000 or more. The funds are endowed, meaning that they will grow in perpetuity and the returns will be used to support your favorite charity.
